What is the Canadian Mining Training Recognition Program?

The Canadian Mining Training Recognition Program (CMTRP) provides a flexible training recognition model that recognizes the alignment of employer, educational institutions and training organizations' training programs to the learning outcomes outlined in the Mining Industry Human Resources Council's (MiHR) National Occupational Training Standards (NOTS). The program is credible and rigorous while also flexible and adaptable for training targeted at operation and production level occupations for which MiHR has National Occupational Standards (NOS).

NOS are the foundation for many workforce development initiatives, and industry has a need and strong interest in a national system to align and recognize training programs that are aligned with the NOTS.

What NOTS Have Been Developed?

The NOTS have either been developed or are in development for the following:

- **Common Competencies:** Foundational skills required for safe conduct at an operating mine or work site.
- Diamond Driller: Occupation specific technical skills
 Driller Disciplines: Occupation specific technical skills
- Minerals Processing Operator: Occupation specific technical skills
- Underground Miner: Occupation specific technical skills
- Frontline Supervisor: Occupation and mining sector specific technical skills
- Industry Trainer: Occupation and mining sector specific technical skills

- Recognition at various meetings and events.

MiHR can support employers, educational institutions and training organizations with \$10,000 to align and enhance existing occupational training to the learning outcomes in MiHR's NOTS.
